

TDR Pilot as an Alternative to MFC

• What is TDR?

- Reporting of transactional sales data instead of tracking Most Favored Customer (MFC) pricing
- Eligibility & Rollout Status
- Benefits Over MFC:
 - Reduces compliance burden
 - Increases pricing flexibility
 - Facilitates streamlined contract administration

Introducing FAS Catalog Platform (FCP)

- What is FCP? FAS Catalog Platform new system replacing SIP
- Key Features:
 - Improved interface for uploading catalog data
 - Automated validations and real-time error feedback
 - Integration with GSA Advantage
- Transition Timeline & Requirements for Vendors
